## Chairman's statement

## 董事長報告書

In 2020, while the global economy at large was severely hit by the continuous spread of COVID-19, China was able to effectively contain the epidemic and her economy rebounded relatively quickly. During the year, China's gross domestic product grew 2.3% versus the drastic slump seen by other major economies around the world. Against this backdrop, Chia Tai Enterprises International Limited (the "Company") and its subsidiaries (together "the Group") braved the challenges stemming from the difficult global economic environment and put in place effective operating strategies to gradually push forward with the overall transformation of the Group's business.

二零二零年,在新型冠狀病毒(「新冠」)疫情持續蔓延的影響下,全球經濟受到沉重打擊,但中國疫情得到有效控制,其經濟恢復的速度較快。年內,中國國民生產總值增長率為2.3%,而全球其他主要經濟體表現則處於異常低迷狀態。在此背景下,正大企業國際有限公司(「本公司」)及其附屬公司(統稱「本集團」)積極應對來自全球艱鉅經濟環境的挑戰,並製定有效的經營策略,逐步推動企業全面轉型。

On the biochemical business front, the agri-food industry in China faced different assails, including COVID-19, the African swine fever and avian flu epidemic. Moreover, China's ban on antibiotics used as animal feed additives took effect on 1 July 2020. The farming industry in China is moving towards low-carbon animal farming trending towards scale production and the integration of production, supply and sale. From the global perspective, while the American, Indian and European markets were harder hit by COVID-19, the Asian market was plagued by the African swine fever and avian flu, dealing a heavy blow to the farming industry. Countering such harsh challenges at home and abroad, the Group responded actively, embracing the quality control principle of focusing on technology, quality first and continuous innovation. With that dedication, the Group managed to raise the quality of its products and achieve better product differentiation. Also, the Group extended the reach of its sales channels from feed mills to farms and pushed at full strength for strategic transformation and sustainable development of its business.

在生化業務方面,中國農牧食品產業除受到新冠疫情、非洲豬瘟及禽流感的三重夾擊,中國飼料行樂」 禁抗也自二零二零年七月一日開始全面執行。中國國內養殖行業正趨向規模化、產供銷一體化,走向低碳養殖。綜觀全球來看,美洲、印度和歐洲豬豬受到新冠疫情較大的影響,亞洲則受到非洲豬豬受到新感的衝擊,為養殖行業造成頗大創傷。師對,實量先行、持續創新的質量方針,實現可產品的品質升級和產品差異化,並推動銷售渠道從飼料廠到養殖場的下沉,全力推動及實現戰略轉型和業務可持續發展。

During the year, the Group embarked on a series of innovation and reforms conducive to the overall transformation and business upgrade. To promote research and innovation, the Group continued to expand its research and development ("R&D") capacity and groom high-end R&D talent, as well as step up cooperation with different higher-education and research institutions. We kicked off different research projects and was able to convert the fruit of such efforts into practical value, thereby sharpened the Group's competitive edge. In operation and production, the Group continued to employ "Six Sigma" management, implementing a series of automation initiatives and optimizing operational flow to boost production efficiency. To raise production safety awareness across the Group, measures were taken to build a work safety ownership culture among employees. The Group also continued its pursuit of green and sustainable operation. Talent recruitment and development are of great importance for the Group. To support its sustainable development over time, the Group has been actively building a talent database and developing a human capital reserve.

年內,在推動全面轉型和升級的過程中,本集團進行了大量的創新和變革。本著全力推動研發創新的策略,不斷的擴充研發實力及培養高端研發人才,以及與各方高校及研發機構深化合作;實現了多個產品項目的研發及成果轉化,增強集團競爭力。在經營和生產過程中,全面推行精益「六西格瑪管理」,推進生產自動化和流程優化,提高生產效率,全面落實主體安全責任意識,持續開展安全文化建設,並致力於綠色環保經營。本集團非常注重人才的引進和培養,積極建立人才信息庫,為集團的可持續發展儲備人力資源。

Chairman's statement 董事長報告書

On the industrial business front, in addition to China effectively and quickly containing the COVID-19 spread, government commitment to infrastructural investments worth tens of billions of Renminbi had given a boost to sales of the construction machinery sector this year. However, despite the climb in sales for the entire industry this year, the Group's market share slipped relative to last year as a result of growing competition from rising local brands. As for China's automobile industry, at the government's increased efforts to drive domestic demand – fostering consumption and spending – the industry saw production and demand steadily increasing. Nevertheless, automobile and motorcycle sales still reported a slight decline for the year. Zhanjiang Deni will enhance its R&D capability, step up production automation and heighten overall operational efficiency, striving to upgrade its technology and seize opportunities bring about by new energy vehicles.

工業業務方面,中國有效及快速控制新冠疫情的擴散和蔓延,加上政府確定推進規模總計達數十萬億人民幣的國內基建投資項目,拉動了今年的工程機械行業銷量。雖然今年的行業銷量有所增長但面對與國產品牌的競爭,本集團的市場佔有率和國內上有所下降。至於中國汽車行業,雖然受惠國內持續推行擴大內需戰略及各項促進消費政策持續短行業生產近期穩中有升,需求企穩回暖,但全年汽車和摩托車銷量還是輕微下降。湛江德利將拓展技術研發,提升自動化生產及整體營運效率,促進技術升級,同時抓好新能源汽車帶來的機會。

Looking ahead, upholding the principle of "benefiting the countries in which we operate, benefiting the people whose community we share and benefiting the enterprises for which we are responsible", we will work hard to ensure the quality of our products and develop superior quality products, strictly abide by environmental laws and regulations, as well as proactively tackle uncertainties in the operating environment. We will also work towards the ends of realising the goal of achieving excellent development and be ready to take on the challenges and capture opportunities in 2021.

展望未來,本集團將秉承「利國、利民、利企業」的價值觀,全力確保產品質量、開發高品質產品,遵守環保相關法律法規,並積極應對經營環境中的不確定因素,落實高質量發展要求,迎向二零二一年的挑戰與機遇。

Finally, I would like to thank all employees for their hard work and contribution in 2020 and also shareholders for their trust and support.



## **GROUP RESULTS**

The Group has two lines of business: biochemical business and industrial business. The biochemical business focuses on the manufacture and/or sale of chlortetracycline ("CTC") and other related products and is carried on by Group subsidiaries. This business segment accounts for all of the Group's consolidated revenue. The industrial business comprises the Group's interests in its joint venture ECI Metro Investment Co., Ltd. (together with its subsidiaries, "ECI Metro") and its associate Zhanjiang Deni Vehicle Parts Co., Ltd. (together with its subsidiaries, "Zhanjiang Deni"). The results of the Group's industrial business are incorporated in the consolidated statement of comprehensive income as share of profits of joint venture and associate.

For the year ended 31 December 2020, the Group's revenue decreased 10.9% to US\$93.58 million (2019: US\$105.04 million). Overall, gross profit margin was 26.6% (2019: 27.6%).

Profit attributable to shareholders of the Company grew 2.9% to US\$16.26 million (2019: US\$15.80 million).

Basic and diluted earnings per share were both US 6.42 cents (2019: US 6.24 cents). The Board has resolved not to declare a final dividend for the year ended 31 December 2020 (2019: Nil).

#### **BUSINESS REVIEW**

#### **Biochemical**

We generate a sizable portion of our revenue from the manufacture and sale of CTC products – CTC Premix and CTC HCL. CTC products are antibiotics used to prevent or cure animal diseases. The Group's customers include pharmaceutical companies, trading companies, feed mills and farms.

In 2020, the Group's revenue from the biochemical business decreased 10.9% to US\$93.58 million (2019: US\$105.04 million). Revenue contribution from China, Asia Pacific (excluding China), Americas, Europe and elsewhere were 39.2%, 30.2%, 18.4%, 8.5% and 3.7%, respectively.

## 集團業績

本集團從事生化業務及工業業務。生化業務專注製造及/或銷售金霉素及其他相關產品,並由本集團之附屬公司營運,乃佔本集團的所有綜合收入。工業業務包含本集團於易初明通投資有限公司(及其附屬公司,統稱「易初明通」)的合營企業權益及於湛江德利車輛部件有限公司(及其附屬公司,統稱「湛江德利」)的聯營公司權益。本集團工業業務的業績載列於綜合全面收益表內的應佔合營企業及聯營公司溢利。

截至二零二零年十二月三十一日止年度,本集團的收入下降10.9%至9,358萬美元(二零一九年:1億504萬美元),整體毛利率為26.6%(二零一九年:27.6%)。

本公司股東應佔溢利增長2.9%至1,626萬美元(二零一九年:1,580萬美元)。

每股基本及攤薄溢利為6.42美仙(二零一九年:6.24 美仙)。董事會決議截至二零二零年十二月三十一 日止年度不派付末期股息(二零一九年:無)。

#### 業務回顧

#### 生化業務

我們的收入大部分來自製造及銷售金霉素產品-金霉素預混劑及鹽酸金霉素。金霉素產品為用作預防或治療禽畜疾病的抗生素。本集團的客戶包括製藥公司、貿易公司、飼料加工廠及養殖場。

二零二零年,本集團生化業務的收入下降10.9%至9,358萬美元(二零一九年:1億504萬美元)。其中,來自中國大陸、亞太地區(不包括中國大陸)、美洲、歐洲及其他地方的收入分別佔39.2%、30.2%、18.4%、8.5%和3.7%。

## **BUSINESS REVIEW (continued)**

#### **Biochemical (continued)**

For the year under review, our biochemical business faced multiple headwinds. For our overseas market, COVID-19 affected the demand for CTC products, causing order cancellations or delays. In China, the Ministry of Agriculture and Rural Affairs of the PRC banned the production of antibiotics for use as animal growth promoters as from 1 January 2020, reducing the domestic sales of our CTC products, as some of such sales were bought for such use in the past.

In 2020, pricing competition in the CTC industry intensified as a result of lower demand in China and overseas, putting pressure on our average selling price. Average selling price of CTC premix, our main revenue contributor, decreased by approximately 2.2% in 2020 when compared to 2019, and the average selling price of CTC HCL also declined 5.7%. Overall, gross profit margin reduced slightly from 27.6% in 2019 to 26.6% in 2020.

The Company previously announced the relocation of the production facilities of Zhumadian Huazhong Chia Tai Co., Ltd. The relocation is to comply with Zhumadian's urban development plans and is expected, at this stage, to be completed in the second half of 2021. A net gain attributable to shareholders of the Company of approximately US\$12.3 million, arising from government compensation, would be recorded upon completion of the relocation.

#### Industrial

The Group's industrial business is conducted through ECI Metro and Zhanjiang Deni.

ECI Metro is principally engaged in the sale, leasing and servicing of Caterpillar machinery equipment in western China. According to the National Bureau of Statistics of the PRC, fixed-asset investment growth in China was 2.9% in 2020 and that in western China itself was 4.4%. For the year ended 31 December 2020, our share of profits of joint venture was US\$12.35 million compared to US\$11.62 million in 2019.

Zhanjiang Deni is principally engaged in the manufacture and sale of automotive parts, which are mainly sold to automobile and motorcycle manufacturers. According to the China Association of Automobile Manufacturers, China motorcycle sales in 2020 was slightly down 0.4% year-on-year and automobile sales was 1.9% lower than 2019. For the year ended 31 December 2020, our share of profits of associate was US\$2.09 million (2019: US\$1.92 million).

#### 生化業務(續)

回顧年內,我們的生化業務面臨多重壓力。海外市場方面,新冠疫情影響了金霉素產品的需求,導致訂單的取消或延誤。在中國,中華人民共和國農業農村部自二零二零年一月一日起禁止生產抗生素作為動物促生長用途,故國內的金霉素產品銷售有所下降,而集團此前某部份的銷售是客戶為此類用途而購買。

二零二零年,由於中國及海外需求下降使金霉素行業的價格競爭加劇,為我們的平均銷售價格增添壓力。我們的主要收入來源金霉素預混料的二零二零年平均銷售價格與二零一九年相比下降了約2.2%,而鹽酸金霉素的平均銷售價格也減少了5.7%。總體而言,毛利率從二零一九年的27.6%輕微下降至二零二零年的26.6%。

本公司於此前宣布駐馬店華中正大有限公司生產設施的搬遷。該搬遷是為配合駐馬店的城市建設規劃要求,而現階段預計將於二零二一年下半年完成。搬遷完成後,政府賠償將使本公司錄得約1,230萬美元的股東應佔淨收益。

#### 工業業務

本集團的工業業務透過易初明通及湛江德利經營。

易初明通主要在中國西部從事卡特彼勒機械設備的銷售、租賃及客戶服務。根據中華人民共和國國家統計局,二零二零年中國固定資產投資按年增長2.9%,其中中國西部錄得4.4%的增長。截至二零二零年十二月三十一日止年度,應佔合營企業溢利為1,235萬美元,而二零一九年為1,162萬美元。

湛江德利專注製造及銷售汽車零件,主要出售予 汽車及摩托車製造商。根據中國汽車工業協會統 計,中國摩托車銷售量於二零二零年按年輕微下降 0.4%,而汽車銷售量則較二零一九年下降1.9%。截 止二零二零年十二月三十一日止年度,應佔聯營公 司溢利為209萬美元(二零一九年:192萬美元)。

## **OUTLOOK**

Uncertainties are expected to linger for the remainder of 2021. While there are positive developments on the vaccine front, the COVID-19 pandemic is likely to affect our biochemical business in overseas market in the short to medium term. The limitation on antibiotic use for animals around the world is also expected to broaden and affect our biochemical business.

For our industrial business, fixed-asset investment growth started to gradually recover in the second half of 2020 and is expected to continue into 2021. However, the Group also expects intense competition from domestic manufacturers in the construction machinery industry.

Overall, we remain cautious about our results in 2021.

## LIQUIDITY AND FINANCIAL RESOURCES

As at 31 December 2020, the Group had total assets of US\$330.7 million, an increase of 13.0% as compared to US\$292.7 million as at 31 December 2019.

As at 31 December 2020, the Group had net cash, being cash less bank borrowings, of US\$11.8 million (31 December 2019: US\$21.8 million).

All the borrowings of the Group are denominated in Renminbi ("RMB") as at 31 December 2020 and 2019.

As at 31 December 2020, the Group's fixed interest rate bank borrowings amounted to US\$7.7 million (31 December 2019: US\$2.9 million).

All domestic sales in mainland China are transacted in RMB and export sales are transacted in foreign currencies. The Group monitors exchange rate movements and determines appropriate hedging activities when necessary.

## **CAPITAL STRUCTURE**

The Group finances its working capital requirements through a combination of funds generated from operations and borrowings. The Group had cash and cash equivalents of US\$32.3 million as at 31 December 2020, a decrease of US\$5.5 million compared to US\$37.8 million as at 31 December 2019.

## 展望

在二零二一年的餘下日子,預計不確定性將持續存在。儘管疫苗方面錄得進展,但新冠疫情仍可能會為我們生化業務的海外市場帶來短期到中期的影響。全球對在動物中使用抗生素的限制預計也會持續擴大,並影響我們的生化業務。

工業業務方面,固定資產投資增長率在二零二零年下半年開始逐漸復甦,預計於二零二一年延續復甦勢頭,但是本集團預計國內工程機械行業製造商間的競爭會持續激烈。

總體而言,我們對二零二一年的業績保持謹慎態度。

## 資金流動性及財政資源

於二零二零年十二月三十一日,本集團之總資產為 3.31億美元,較二零一九年十二月三十一日之2.93 億美元,增加13.0%。

於二零二零年十二月三十一日,本集團之淨現金,即現金減銀行借款為1,180萬美元(二零一九年十二月三十一日:2,180萬美元)。

本集團於二零二零年及二零一九年十二月三十一日的借款全部按人民幣作為單位。

於二零二零年十二月三十一日,本集團按固定利率計息之借款為770萬美元(二零一九年十二月三十一日:290萬美元)。

於中國大陸所有國內銷售均以人民幣計算,而出口 銷售則以外幣計算。本集團監控外滙變動,必要時 考慮適當的對沖活動。

#### 資本結構

本集團透過營運資金及借款應付其流動資金需求。 於二零二零年十二月三十一日,本集團持有現金及 現金等價物3,230萬美元(二零一九年十二月三十一 日:3,780萬美元),減少550萬美元。

## **CHARGES ON GROUP ASSETS**

As at 31 December 2020, out of the total borrowings of US\$20.5 million (31 December 2019: US\$16.0 million) obtained by the Group, US\$15.1 million (31 December 2019: US\$13.1 million) was secured and accounted for 73.5% (31 December 2019: 82.0%) of the total borrowings. Certain of the Group's property, plant and equipment and land lease prepayments with an aggregate net book value of US\$11.3 million (31 December 2019: US\$11.0 million) were pledged as security.

#### **CONTINGENT LIABILITIES**

As at 31 December 2020, the Group did not have any significant contingent liabilities.

## SIGNIFICANT INVESTMENTS HELD, MATERIAL ACQUISITIONS AND DISPOSALS

Save for those disclosed in this annual report, there were no other significant investments held nor material acquisitions or disposals during the year.

## **EMPLOYEE AND REMUNERATION POLICIES**

As at 31 December 2020, the Group employed around 900 employees in the PRC and Hong Kong. The Group remunerates its employees based on their performance, experience and prevailing market conditions while performance bonuses are granted on a discretionary basis. Other employee benefits include, for example, medical insurance and training.

## THE BOARD

#### (a) Board Composition

As at the date of this report, the board of directors of the Company (the "Board") comprises nine members, including four executive directors, two non-executive directors and three independent non-executive directors.

The biographical details of the directors of the Company (the "Directors") and the relationships among the Directors are set out in the Biographical Details of Directors section in the annual report.

#### (b) Chairman and Chief Executive

Mr. Soopakij Chearavanont is the Chairman of the Company. Mr. Thirayut Phityaisarakul and Mr. Thanakorn Seriburi are the Chief Executive Officers of the biochemical division and the industrial division respectively. The roles of the Chairman and the Chief Executive Officers are distinct and separate with a clear division of responsibilities. The Chairman is responsible for overseeing the function of the Board while the Chief Executive Officers are responsible for managing the Group's business.

#### (c) Roles and Responsibilities

The Board, directly and through its committees, leads and provides direction for the management by laying down strategies and overseeing their implementation by the management, reviews the operational and financial performance, provides oversight to ensure that a sound system of risk management and internal control is in place, and performs corporate governance functions.

The non-executive Directors (including the independent non-executive Directors) provide advisory as well as checks and balances for effective and constructive contribution to the Board to safeguard interests of the shareholders of the Company (the "Shareholders") and the Company as a whole.

The management is responsible for execution of business strategies and dealing with day-to-day operations.

#### (d) Independent Non-executive Directors

The Company has received from each of the independent non-executive Directors an annual confirmation of his independence pursuant to Rule 3.13 of the Listing Rules and considers that all independent non-executive Directors are independent.

#### (e) Directors' Securities Transactions

The Company has adopted the Code of Conduct for Securities Transactions, which is based on the required standard set out in Appendix 10 of the Listing Rules – Model Code for Securities Transactions by Directors of Listed Issuers, as the code of conduct for dealings in the Company's securities by its directors. All Directors responded to a specific enquiry by the Company and confirmed that they complied with the required standard set out in the Code of Conduct for Securities Transactions during 2020.

In general, whilst the Company is in a growth stage, the Board does not expect, in the absence of special circumstances, to declare or recommend any dividend.
- 5. This dividend policy is subject to review by the Board and may be amended by the Board.

The Remuneration Committee consists of three independent non-executive Directors, Mr. Cheng Yuk Wo (Chairman), Mr. Surasak Rounroengrom and Mr. Edward Ko Ming Tung, and an executive Director, Mr. Thanakorn Seriburi.

The Remuneration Committee is delegated by the Board with the primary responsibilities to make recommendations to the Board on remuneration policy and structure for the directors as well as to consider and recommend to the Board the remuneration packages of the individual director.

The primary objective of the Remuneration Committee is to ensure that the Company is able to attract, retain and motivate high-caliber employees who are critical to the success of the Company, thereby enhancing the value of the Company to the Shareholders. The objective of the Company's remuneration policy is to maintain fair and competitive packages based on business requirements and industry practices.

During 2020, the Remuneration Committee held two meetings to consider and recommend to the Board the remuneration packages of the individual director and other remuneration matters.

Details of the remuneration of each Director are set out in note 9 to the financial statements in the annual report.

#### (iii) Nomination Committee

The Nomination Committee consists of a non-executive Director, Mr. Soopakij Chearavanont (Chairman) and two independent non-executive Directors, Mr. Surasak Rounroengrom and Mr. Cheng Yuk Wo.

The Nomination Committee is delegated by the Board with the primary responsibilities to formulate and implement the nomination policy and board diversity policy, make recommendations to the Board on the selection of any individual nominated for directorship and assess the independence of independent non-executive Directors.

The non-executive Directors and independent non-executive Directors are appointed for successive terms of one year and three years respectively. All Directors are subject to retirement by rotation, but may offer themselves for re-election at annual general meetings in accordance with the Company's bye-laws. According to the Company's bye-laws, at each annual general meeting of the Company, no less than one-third of the Directors for the time being shall retire from office by rotation, provided that every Director shall be subject to retirement at an annual general meeting at least once every three years.



2.3 The candidates shall timely provide such information and documents relating to their nomination as the Nomination Committee or the Board may request, including but not limited to any such information as is required for disclosure under the Listing Rules and their written consent to be elected as Directors and to the public disclosure of their information.

#### 3 Nomination Rules and Procedures

- 3.1 The Secretary of the Nomination Committee shall call a meeting of the Nomination Committee and in advance of the meeting invite nomination of candidates from members of the Board, if any, for consideration by the Nomination Committee. The Nomination Committee may put forward other candidates irrespective of whether such candidates have been nominated by members of the Board.
- 3.2 The Nomination Committee shall, upon receipt of all necessary information relating to the candidates, evaluate each of such candidates at the meeting based on the criteria set out in Section 2 above to determine whether to make a nomination to the Board.

- 3.4 The Board shall have the final decision on all matters relating to the appointment of candidates as Directors and its recommendation of candidates to stand for election at any general meeting.
- 3.5 Any proposed candidate is entitled to withdraw his/her candidature at any time before the meeting of the Board at which his appointment is to be considered or the general meeting at which he/she is to stand for election by serving a notice in writing to the Company.

#### 4 Confidentiality

Unless required by law or any regulatory authority, under no circumstances may a member of the Nomination Committee disclose any information to the public with regard to any nomination or candidature whilst such information has not been disclosed by the Company to the public.

#### 5 Review

The Nomination Committee will review this nomination policy from time to time, as appropriate, and discuss any revisions that may be considered appropriate, including to ensure that it remains relevant to the Company's needs and reflects both current regulatory requirements and good corporate governance practice, and recommend them to the Board for approval.

## RISK MANAGEMENT AND INTERNAL CONTROL

#### **Our Approach**

The Group has established and adopted a risk management policy which is designed to manage the risk of failure associated with the Group while achieving its business objectives and to provide reasonable, but not absolute, assurance against material misstatement or loss. A risk appetite statement has been established to define the extent of risks that the Group is willing to take in pursuit of its strategies and business objectives.

Clear roles and responsibilities are assigned to different level of management within the Group. The Board acknowledges that it is responsible for the Group's risk management and internal control systems. The Board also (i) oversees the design, implementation and monitoring of the risk management and internal control systems and (ii) evaluates and determines the nature and extent of risks it is willing to take in achieving the Group's business objectives. The Board delegates the responsibility of reviewing the effectiveness of the Group's risk management and internal control systems to the Audit Committee, which monitors the Group's risk management and internal control systems through the Internal Audit Department. The Internal Audit Department carries out independent review of key business processes and controls, key findings and recommendations for improvement are regularly reported to the Audit Committee. The external auditor also reports any control issues which have been identified in the course of audit or review work to the Audit Committee. Management is responsible for designing, implementing and monitoring risk management and internal control systems, whereas risk owners appointed by the management are responsible for identifying, analysing and prioritising risk issues for further consideration by management, and ensuring that the risk monitoring and control system are working effectively and risk mitigation actions are implemented timely within business units.

#### **Effectiveness Review**

In 2020, the Audit Committee, on behalf of the Board, conducted an annual review of the effectiveness of the Group's risk management and internal control systems. The Board considers that the risk management and internal control systems of the Group are effective and adequate. The Board also considers that the Group has adequate resources, staff qualifications and experience, training programmes and budget for accounting, internal audit and financial reporting functions.

## **Continuous Improvement**

We are committed to improve our risk management and internal control framework and will continue to enhance the integration of risk management and internal control into our business process.

For handling and dissemination of inside information, an inside information handling policy is in place to enable the Group to handle inside information in accordance with legal requirements and, where required, communicate with the Group's stakeholders in a timely manner.

## SHAREHOLDERS' RIGHTS

#### Convening a Special General Meeting by Shareholders

In accordance with the Company's bye-laws, the Board may, whenever it thinks fit, convene a special general meeting, and special general meetings shall also be convened on requisition, as provided by the Companies Act 1981 of Bermuda (as the same may from time to time be amended) (the "Companies Act"), and, in default, may be convened by the requisitionists.

Pursuant to the Companies Act, at the date of the deposit of the requisition, members holding not less than one-tenth of the paid-up capital of the Company carrying the right of voting at general meetings of the Company can submit a written requisition to the Board for convening a special general meeting.

The requisition must state the purposes of the meeting, and must be signed by the requisitionists and deposited at the registered office of the Company.

If the Board fails to convene a meeting within twenty-one days from the date of the deposit of the requisition, the requisitionists, or any of them representing more than one half of the total voting rights of all of them, may themselves convene a meeting, but any meeting so convened shall not be held after the expiration of three months from the date of the written requisition.

Such meeting convened by the requisitionists shall be convened in the same manner as that in which meetings are to be convened by the Board. At least fourteen clear days' notice in writing (and not less than ten business days) shall be given to all members of the Company.

#### To Make Enquiry to the Board

Shareholders can make enquiry to the Board by writing to the principal place of business of the Company in Hong Kong.

#### To Put Forward Proposals at General Meetings

Pursuant to the Companies Act, any number of members of the Company representing not less than one-twentieth of the total voting rights of all the members having at the date of the requisition a right to vote at the meeting to which the requisition relates, or not less than one hundred members, can submit a written requisition to the Board for putting forward proposals at general meetings.

The requisition must state the resolution with a statement of not more than one thousand words with respect to the matter referred to in the proposed resolution or state the business to be dealt with at that meeting, and the requisition must be signed by the requisitionists.

The requisition must be deposited at the registered office of the Company no less than six weeks before the meeting in the case of the requisition requiring notice of a resolution or no less than one week before the meeting in case of any other requisition. The requisitionists must deposit a sum of money reasonably sufficient to meet the Company's expenses in serving the notice of the resolution and circulating the statement to all members of the Company.

#### To Propose a Person for Election as a Director

Members of the Company (other than the person to be proposed) who are qualified to attend and vote at general meetings of the Company can submit a written requisition to the Board to propose a person for election as a director of the Company at a general meetings.

The requisition must be signed by the requisitionists and deposited, with a notice signed by the nominated candidate of his/her willingness to be elected and the candidate's information required to be disclosed under Rule 13.51(2) of the Listing Rules and a written consent from the nominated candidate to the publication of his/her personal data, at the principal place of business of the Company in Hong Kong no earlier than the day after the despatch of the notice of the general meeting at which the candidate is proposed for election, and ending no later than seven days prior to the date of such general meeting.

Details of the procedures for proposing a person for election as a director are available on the Company's website.

#### **INVESTOR RELATIONS**

The Board has established a shareholders' communication policy setting out the principles in relation to communication with the Shareholders, with the objective of maintaining full, open and timely communication with the Shareholders. Information would be communicated to Shareholders in a timely manner, mainly through the publication of the Company's corporate communications including interim and annual reports, announcements and circulars. These publications are available on the Company's website.

The Group is principally engaged in the manufacture and/or sale of chlortetracycline ("CTC") and other related products. Additionally, the Group is also involved, through its joint venture and its associated company, in the trading of machinery and the manufacture and sale of automotive parts.

#### Reliance on Key Products

Sales of CTC Premix account for a substantial portion of the Group's revenue. Any factors adversely affecting the pricing of, demand for, consumer preferences for, regulatory requirements of, or market acceptance of CTC Premix, including any increase in competition, change in government regulatory requirements, negative findings or publicity on the effects of CTC Premix, could cause the Group's revenue to decline and the Group's business and future operating results to suffer.

#### Volatility of Commodity Prices

The principal raw materials used to manufacture CTC products are corn starch, yeast, peanut meal and soybean meal. The availability and prices of the necessary raw materials may be adversely affected by factors beyond the Group's control, such as weather conditions, natural disasters or a sudden surge in demand.

If the supply of raw materials is disrupted to a material degree or if there is a substantial increase in the prices of raw materials, and the Group is not able to purchase the same raw materials of the same quality from alternative suppliers at competitive prices or to transfer such material price increase to customers, the Group's financial condition and operating results may be materially and adversely affected. Management will set a safety stock level and continuously collect and analyse the commodity prices information when purchasing these raw materials.

#### Market Competition

The Group faces intense competition from other CTC producers. New players may also enter the market, competing with the Group's existing clients and negatively impacting the Group's market share.

#### **Product Liability**

If the Group's products fail to perform as expected, or prove to be defective or result in accidents, personal injuries, casualties or financial losses to customers, the Group may be subject to liability claims for damages. If products do not meet the specifications and requirements requested by customers, or if any of the Group's products are defective, such defects or any complaints or negative publicity resulting therefrom could result in decreased sales of the Group's products, and the Group may also be subject to product liability claims and litigation. The Group's internal quality control team oversees quality assurance controls and systems throughout the production process.

#### Licenses and Permits

In accordance with applicable PRC laws and regulations, the Group is required to obtain and maintain various licences and permits in order to commence and operate our business. In addition, in order to export and sell CTC products overseas, the Group needs to obtain various government approvals and comply with applicable standards in relation to production processes, premises and CTC products in the countries where the Group sell CTC products.

#### Licenses and Permits (continued)

Although the Group currently has the necessary licences and permits, the eligibility criteria for such licences and permits may change from time to time and may become more stringent. In addition, new requirements for the grant or renewal of such licences and permits may come into effect in the future. The introduction of any such new and/or more stringent laws or regulations may significantly escalate the compliance and maintenance costs or may limit or even prohibit the Group to continue its existing operations or expand its business. Management continuously keeps abreast of regulatory changes in the relevant laws and regulations on licenses and permits.

#### Disease Outbreak

Any animal disease outbreak, such as bird flu and African swine fever, may cause widespread animal death, and hence would affect demand for our products and results of the Group. Further, any human disease outbreak, such as COVID-19, may also disrupt the Group's business, including delay in raw material supply, workforce availability due to people movement restrictions and outbound logistical delays in our delivery of products to customers. The Group will monitor the situation and adopt appropriate measures to minimize the impact on the Group's business and operation.

#### Environmental Compliance

Our CTC production is required to comply with applicable environmental protection laws and regulations in the PRC which govern the standards of air pollution, waste water discharge and noise emissions. Local PRC government and authorities generally have the authority delegated by relevant laws and regulations to impose penalties on companies failing to comply with the relevant environmental protection laws and regulations.

In addition to the existing environmental protection laws and regulations, the PRC government may promulgate new and stricter environmental protection laws and regulations in the biochemical industry in the future which may apply to the Group. As a result, compliance with such legal requirements will become more burdensome and we may incur additional costs in production process and operations, which may ultimately adversely affect production and results of operations. The Safety, Health and Environmental Committee of the Group oversees relevant environmental policies affecting the Group's operations.

The Group strives to comply in all material aspects with the relevant laws and regulations which are regarded as having a significant impact on the Group, and has not come across incidence of material breach or non-compliance during 2020.

#### **Employees**

We highly value our talents and are committed to providing a safe work environment to our employees. The Group remunerates its employees based on their performance, experience and prevailing market rates while performance bonuses are granted on a discretionary basis. Other employee benefits include, for example, medical insurance and training. We also ensure our recruitment policies are in compliance with national regulations in the areas of equal opportunity and anti-discrimination.

We have in place safety guidelines and operating manuals setting out safety measures for the production processes. In accordance with applicable laws and regulations in China, we provide our employees with training programs on work safety including trainings on safe usage of chemicals and machineries, accident prevention and management. We also conduct regular inspections on our machineries to ensure compliance with safety standards.

#### Customers

We strive to provide products of the highest quality to our customers. Our operations are certified with ISO 9001, GMP and we have stringent internal quality control procedures in place. We have set up our own laboratories to conduct product testing as part of our internal quality assurance. To monitor our customers' satisfaction, the Group's sales teams listen to customers' needs and opinions. With the continuous feedback of our customers, we will continue to improve our product and service qualities.

The Share Option Scheme was established for the purpose of providing incentives and rewards to eligible persons who contribute to the success of the Group's operations. Eligible persons of the Share Option Scheme include the Company's directors, senior executives, employees of the Group and those persons that, in the opinion of the Directors, have contributions or potential contributions to the Group.

The total number of ordinary shares which may be issued upon exercise of all options to be granted under the Share Option Scheme shall not in aggregate exceed 24,071,831 shares, being 10% of the total number of ordinary shares of the Company in issue on the date of listing on 3 July 2015.

The maximum number of ordinary shares issuable upon exercise of share options granted under the Share Option Scheme was 24,071,831 ordinary shares, representing 10% of the issued ordinary shares of the Company as at the date of this report.

The maximum number of ordinary shares issuable upon exercise of the share options granted to each eligible person under the Share Option Scheme within any 12-month period is limited to 1% of the ordinary shares of the Company in issue. Any further grant of share options in excess of this limit is subject to the Shareholders' approval in advance in a general meeting.

("Pucheng CT Biochem")) entered into a framework agreement with Local State-owned Fujian Province Pucheng County Biochemical Factory and Pucheng County Xingly Arts & Craft Co. Ltd. (collectively the "Vendors", holding 15.27% and 0.53% of the equity interests respectively in Pucheng CT Biochem) under which the Vendors agreed to initiate the procedure under the prescribed requirements for the transfer of the state-owned assets in the PRC for the sale of their equity interests in Pucheng CT Biochem. Subject to the Vendors having obtained the governmental approval for the transactions under the framework agreement, the Purchasers would pay the Vendors RMB20 million as earnest money in accordance with the terms of the framework agreement.

As at 24 December 2020, being the date of the Company's announcement, Local State-owned Fujian Province Pucheng County Biochemical Factory was a substantial shareholder of Pucheng CT Biochem and was therefore a connected person of the Company at the subsidiary level. For the year ended 31 December 2020, the approved annual cap for the transactions contemplated under the 2020 Supplemental HOEL Purchase Agreement was US\$7,800,000 and the actual sales recorded amounted to US\$8,461,000. On 5 March 2021 following the discovery of the non-compliance, the Company made the annual cap of 2020 and also proposed to increase the annual caps for 2021 to 2023, and convened a special general meeting on 23 April 2021 to rectify the transactions under the 2020 Supplemental HOEL Purchase Agreement and the actual transaction amount thereunder and approve the increased annual caps for 2021 to 2023. These matters were subsequently approved by independent shareholders at the special general meeting.

# **Opinion**

We have audited the consolidated financial statements of Chia Tai Enterprises International Limited (the "Company") and its subsidiaries (together the "Group") set out on pages 50 to 56, which comprise the consolidated statement of financial position as at 31 December 2020, the consolidated statement of comprehensive income, the consolidated statement of changes in equity and the consolidated statement of cash flows for the year then ended and notes to the consolidated financial statements, including a summary of significant accounting policies.

#### The key audit matter

The Group's revenue is mainly derived from the sale of biochemical products. The Group generally recognises revenue when products are delivered to the customer's premises for domestic sales or in accordance with the terms and conditions of sale for export sales.

The terms set out in the Group's sales contracts relating to goods acceptance by customers are varied. Accordingly, the terms and conditions of sales contracts may affect the timing of recognition of sales to customers as each sales contract could have different terms relating to customer acceptance of the goods sold.

We identified the recognition of revenue as a key audit matter because revenue is one of the key performance indicators of the Group and is, therefore, subject to an inherent risk of manipulation by management to meet targets or expectations and because errors in the recognition of revenue could have a material impact on the Group's profit for the year.

#### How the matter was addressed in our audit

Our audit procedures to assess the recognition of revenue included the following:

- evaluating the design, implementation and operating effectiveness of key internal controls over the existence, accuracy and timing of revenue recognition;
- challenging the revenue recognition policies adopted by the Group by making inquiries of management and inspecting a sample of sales contracts to understand the delivery terms of the transactions and to assess the Group's timing of revenue recognition with reference to the requirements of the prevailing accounting standards;
- inspecting manual adjustments to revenue raised during the reporting period which met specific riskbased criteria, enquiring of management the reasons for such adjustments and comparing the details of the adjustments with relevant underlying documentation;
- assessing whether revenue had been recognised in the appropriate accounting period by comparing a sample of sales transactions around the year end with relevant underlying documents, which included customers' signed acknowledgement of receipt (for domestic sales) and bills of lading (for export sales); and
- identifying significant sales returns from the sales ledger after the year end and inspecting the underlying documentation to assess if the related adjustments to revenue had been accounted for in the appropriate accounting period.

#### 1 GENERAL INFORMATION

Chia Tai Enterprises International Limited (the "Company") is a limited liability company incorporated in Bermuda. The Company and its subsidiaries hereinafter are collectively referred to as the "Group". The Group and its joint venture and associate are principally involved in (i) manufacturing and/or sale of chlortetracycline and other related products; (ii) trading of machinery; and (iii) manufacturing and sale of automotive parts respectively.

At 31 December 2020, the directors consider the immediate holding company of the Company to be Charoen Pokphand Foods Public Company Limited ("CPF"), which is incorporated in the Kingdom of Thailand and shares of which are listed on the Stock Exchange of Thailand, and remains to be as such as at the date of approval of these financial statements. CPF is a significantly owned company of Charoen Pokphand Group Company Limited ("CPG"), which is incorporated in the Kingdom of Thailand.

#### 2.1 BASIS OF PREPARATION

These financial statements have been prepared in accordance with International Financial Reporting Standards ("IFRSs") (which include all International Financial Reporting Standards, International Accounting Standards ("IASs") and interpretations) issued by the International Accounting Standards Board ("IASB") and the disclosure requirements of the Hong Kong Companies Ordinance. These financial statements also comply with the applicable disclosure provisions of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "Listing Rules"). The financial statements of the subsidiaries are prepared for the same reporting period as the Company, using consistent accounting policies.

#### **Basis of measurement**

These financial statements are presented in United States dollars ("US\$"), and all values are rounded to the nearest thousand ("US\$'000") except when otherwise indicated. The functional currency of the Company is United States dollars.

### 1 一般資料

# 2.1 編製基準

#### Use of estimates and judgements

The preparation of these financial statements in conformity with IFRSs requires management to make judgements, estimates and assumptions that affect the application of policies and reported amounts of assets, liabilities, income and expenses. The estimates and assumptions are based on historical experience and various other factors that are believed to be reasonable under the circumstances, the results of which form the basis of making the judgements about carrying values of assets and liabilities that are not readily apparent from other sources. Actual results may differ from these estimates.

The estimates and assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

Judgements made by management in the application of IFRSs that have significant effect on these financial statements and major sources of estimation uncertainty are discussed in note 3.

# 2.2 CHANGES IN ACCOUNTING POLICY AND DISCLOSURES

#### (a) Subsidiaries and non-controlling interests

Subsidiaries are entities controlled by the Group. The Group controls an entity when it is exposed to, or has rights to, variable returns from its involvement with the entity and has the ability to affect those returns through its power over the entity. When assessing whether the Group has power, only substantive rights (held by the Group and other parties) are considered.

An investment in a subsidiary is consolidated into these financial statements from the date that control commences until the date that control ceases. Intra-group balances, transactions and cash flows and any unrealised profits arising from intra-group transactions are eliminated in full in preparing these financial statements. Unrealised losses resulting from intra-group transactions are eliminated in the same way as unrealised gains but only to the extent that there is no evidence of impairment.

Non-controlling interests represent the equity in a subsidiary not attributable directly or indirectly to the Company, and in respect of which the Group has not agreed any additional terms with the holders of those interests which would result in the Group as a whole having a contractual obligation in respect of those interests that meets the definition of a financial liability. For each business combination, the Group can elect to measure any non-controlling interests either at fair value or at the non-controlling interests' proportionate share of the subsidiary's net identifiable assets.

Non-controlling interests are presented in the consolidated statement of financial position within equity, separately from equity attributable to the equity shareholders of the Company. Non-controlling interests in the results of the Group are presented on the face of the consolidated statement of comprehensive income as an allocation of the total profit or loss and total comprehensive income for the year between non-controlling interests and the equity shareholders of the Company. Loans from holders of non-controlling interests and other contractual obligations towards these holders are presented as financial liabilities in the consolidated statement of financial position in accordance with notes 2.4(h) or (i) depending on the nature of the liability.

Changes in the Group's interests in a subsidiary that do not result in a loss of control are accounted for as equity transactions, whereby adjustments are made to the amounts of controlling and non-controlling interests within consolidated equity to reflect the change in relative interests, but no adjustments are made to goodwill and no gain or loss is recognised.

When the Group loses control of a subsidiary, it is accounted for as a disposal of the entire interest in that subsidiary, with a resulting gain or loss being recognised in profit or loss. Any interest retained in that former subsidiary at the date when control is lost is recognised at fair value and this amount is regarded as the fair value on initial recognition of a financial asset or, when appropriate, the cost on initial recognition of an investment in an associate or joint venture (see note 2.4(b)).

In the Company's statement of financial position, an investment in a subsidiary is stated at cost less impairment losses (see note 2.4(e)(ii)).

### (b) Associate and joint venture

An associate is an entity in which the Group or Company has significant influence, but not control or joint control, over its management, including participation in the financial and operating policy decisions. Significant influence is presumed to exist when the Group holds between 20% and 50% of the voting power of another entity.

A joint venture is an arrangement whereby the Group or Company has joint control, established by contracts requiring unanimous consent for decisions about the activities that significantly affect the arrangements' returns.

An investment in an associate or a joint venture is accounted for in these financial statements under the equity method, unless it is classified as held for sale (or included in a disposal group that is classified as held for sale). Under the equity method, the investment is initially recorded at cost, adjusted for any excess of the Group's share of the acquisition-date fair values of the investee's identifiable net assets over the cost of the investment (if any). Thereafter, the investment is adjusted for the post acquisition change in the Group's share of the investee's net assets and any impairment loss relating to the investment (see note 2.4(e)(ii)). At each reporting date, the Group assesses whether there is any objective evidence that the investment is impaired. Any acquisition-date excess over cost, the Group's share of the post-acquisition, post-tax results of the investees and any impairment losses for the year are recognised in profit or loss, whereas the Group's share of the post-acquisition post-tax items of the investees' other comprehensive income is recognised as other comprehensive income.

When the Group's share of losses exceeds its interest in the associate or the joint venture, the Group's interest is reduced to nil and recognition of further losses is discontinued except to the extent that the Group has incurred legal or constructive obligations or made payments on behalf of the investee. For this purpose, the Group's interest is the carrying amount of the investment under the equity method together with the Group's long-term interests that in substance form part of the Group's net investment in the associate or the joint venture.

Unrealised profits and losses resulting from transactions between the Group and its associate and joint venture are eliminated to the extent of the Group's interest in the investee, except where unrealised losses provide evidence of an impairment of the asset transferred, in which case they are recognised immediately in profit or loss.

If an investment in an associate becomes an investment in a joint venture or vice versa, retained interest is not remeasured. Instead, the investment continues to be accounted for under the equity method.

In all other cases, when the Group ceases to have significant influence over an associate or joint control over a joint venture, it is accounted for as a disposal of the entire interest in that investee, with a resulting gain or loss being recognised in profit or loss. Any interest retained in that former investee at the date when significant influence or joint control is lost is recognised at fair value and this amount is regarded as the fair value on initial recognition of a financial asset.

#### Property, plant and equipment

Items of property, plant and equipment, other than construction in progress, are stated at cost less accumulated depreciation and impairment losses (see note 2.4(e)(ii)):

- (i) buildings held for own use which are situated on leasehold land; and
- (ii) other items of plant and equipment.

The cost of self-constructed items of property, plant and equipment includes the cost of materials, direct labour, the initial estimate, where relevant, of the costs of dismantling and removing the items and restoring the site on which they are located, and an appropriate proportion of production overheads and borrowing costs (see note 2.4(p)).

Gains or losses arising from the retirement or disposal of an item of property, plant and equipment are determined as the difference between the net disposal proceeds and the carrying amount of the item and are recognised in profit or loss on the date of retirement or disposal.

Depreciation is calculated on the straight-line basis to write off the cost of items of property, plant and equipment to their estimated residual value over the estimated useful life. The principal annual rates used for this purpose are as follows:

Property, plant and equipment (continued)

Where parts of an item of property, plant and equipment have different useful lives, the cost of the item is allocated on a reasonable basis between the parts and each part is depreciated separately. Both the useful life of an asset and its residual value, if any, are reviewed annually.

#### Construction in progress

Construction in progress represents the silos, factories and warehouses under construction. Construction in progress is stated at cost less any accumulated impairment losses, and is not depreciated. Cost comprises the direct costs of construction and capitalised borrowing costs on related borrowed funds during the period of construction. Construction in progress is reclassified to the appropriate category of property, plant and equipment when completed and ready for use.

#### (d) Leased assets

At inception of a contract, the Group assesses whether the contract is, or contains, a lease. A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration. Control is conveyed where the customer has both the right to direct the use of the identified asset and to obtain substantially all of the economic benefits from that use.

Where the contract contains lease components and non-lease components, the Group has elected not to separate non-lease components and accounts for each lease component and any associated non-lease components as a single lease component for all leases.

At the lease commencement date, the Group recognises a right-of-use asset and a lease liability, except for short-term leases that have a lease term of 12 months or less and leases of low-value assets. When the Group enters into a lease in respect of a low-value asset, the Group decides whether to capitalise the lease on a lease-by-lease basis. The lease payments associated with those leases which are not capitalised are recognised as an expense on a systematic basis over the lease term.

Where the lease is capitalised, the lease liability is initially recognised at the present value of the lease payments payable over the lease term, discounted using the interest rate implicit in the lease or, if that rate cannot be readily determined, using a relevant incremental borrowing rate. After initial recognition, the lease liability is measured at amortised cost and interest expense is calculated using the effective interest method. Variable lease payments that do not depend on an index or rate are not included in the measurement of the lease liability and hence are charged to profit or loss in the accounting period in which they are incurred.

The right-of-use asset recognised when a lease is capitalised is initially measured at cost, which comprises the initial amount of the lease liability plus any lease payments made at or before the commencement date, and any initial direct costs incurred. Where applicable, the cost of the right-of-use assets also includes an estimate of costs to dismantle and remove the underlying asset or to restore the underlying asset or the site on which it is located, discounted to their present value, less any lease incentives received.

- fixed-rate financial assets, trade and other receivables: effective interest rate determined at initial recognition or an approximation thereof; and
- variable-rate financial assets: current effective interest rate.

#### Measurement of ECLs (continued)

The maximum period considered when estimating ECLs is the maximum contractual period over which the Group is exposed to credit risk.

In measuring ECLs, the Group takes into account reasonable and supportable information that is available without undue cost or effort. This includes information about past events, current conditions and forecasts of future economic conditions.

ECLs are measured on either of the following bases:

- 12-month ECLs: these are losses that are expected to result from possible default events within the 12 months after the reporting date; and
- lifetime ECLs: these are losses that are expected to result from all possible default events over the expected lives of the items to which the ECL model applies.

Loss allowances for trade receivables are always measured at an amount equal to lifetime ECLs. ECLs on these financial assets are estimated using a provision matrix based on the Group's historical credit loss experience, adjusted for factors that are specific to the debtors and an assessment of both the current and forecast general economic conditions at the reporting date.

Inventories are carried at the lower of cost and net realisable value.

Cost is calculated using the weighted average cost formula and comprises all costs of purchase, costs of conversion and other costs incurred in bringing the inventories to their present location and condition.

Net realisable value is the estimated selling price in the ordinary course of business less the estimated costs of completion and the estimated costs necessary to make the sale.

When inventories are sold, the carrying amount of those inventories is recognised as an expense in the period in which the related revenue is recognised. The amount of any write-down of inventories to net realisable value and all losses of inventories are recognised as an expense in the period the write-down or loss occurs. The amount of any reversal of any write-down of inventories is recognised as a reduction in the amount of inventories recognised as an expense in the period in which the reversal occurs.

#### (g) Trade and other receivables

Trade and other receivables are initially recognised at fair value and thereafter stated at amortised cost using the effective interest method, less allowance for credit losses (see note 2.4(e)), except where the receivables are interest-free loans made to related parties without any fixed repayment terms or the effect of discounting would be immaterial. In such cases, the receivables are stated at cost less allowance for credit losses.

Interest-bearing borrowings are recognised initially at fair value less attributable transaction costs. Subsequent to initial recognition, interest-bearing borrowings are stated at amortised cost with any difference between the amount initially recognised and redemption value being recognised in profit or loss over the period of the borrowings, together with any interest and fees payable, using the effective interest method.

#### (i) Trade and other payables

Trade and other payables are initially recognised at fair value. Trade and other payables are subsequently stated at amortised cost unless the effect of discounting would be immaterial, in which case they are stated at cost.

#### (j) Cash and cash equivalents

Cash and cash equivalents comprise cash at bank and on hand, demand deposits with banks, and short-term, highly liquid investments that are readily convertible into known amounts of cash and which are subject to an insignificant risk of changes in value, having been within three months of maturity at acquisition. Bank overdrafts that are repayable on demand and form an integral part of the Group's cash management are also included as a component of cash and cash equivalents for the purpose of the consolidated statement of cash flows.

Salaries, annual bonuses, paid annual leave and the cost of non-monetary benefits are accrued in the year in which the associated services are rendered by employees. Where payment or settlement is deferred and the effect would be material, these amounts are stated at their present values.

Termination benefits are recognised at the earlier of when the Group can no longer withdraw the offer of those benefits and when it recognises restructuring costs involving the payment of termination benefits.

The Group operates a defined contribution Mandatory Provident Fund benefit scheme (the "MPF Scheme") under the Mandatory Provident Fund Schemes Ordinance, for those employees who are eligible to participate in the MPF Scheme. Contributions are made based on a percentage of the employees' basic salaries and are charged to profit or loss as they become payable in accordance with the rules of the MPF Scheme in Hong Kong. The assets of the MPF Scheme are held separately from those of the Group in an independently administered fund. The Group's employer contributions vest fully with the employees when contributed into the MPF Scheme.

Certain provinces, autonomous regions or municipalities are overburdened by the pension insurance due to higher number of retired people, it is required to make specific contributions at rates higher than 16% (before 1 May 2019: 20%) (the percentage to be determined by each of the government of the provinces, autonomous regions or municipalities) of the total salaries of the employees upon approval of the ministry of labour and the ministry of finance. The PRC government is responsible for the pension liability to the retired employees. The employees of the subsidiaries are entitled to a monthly pension at their retirement dates. The subsidiaries have no further obligation for post-retirement benefits beyond the annual contributions.

For a contract where the period between the payment by the customer and the transfer of the promised goods or services is one year or less, the transaction price is not adjusted for the effects of a significant financing component, applying the practical expedient in paragraph 63 of IFRS 15. If the products are a partial fulfilment of a contract covering other goods and/or services, then the amount of revenue recognised is an appropriate proportion of the total transaction price under the contract, allocated between all the goods and services promised under the contract on a relative stand-alone selling price basis. As the remaining performance obligations (if any) is part of a contract that has an original expected duration of one year or less, the Group has applied the practicable expedient in paragraph 121 of IFRS 15 and such information is not disclosed. Besides, the Group recognises the incremental costs of obtaining a contract as an expense when incurred if the amortisation period of the assets that the Group otherwise would have recognised is within one year or less, applying the practical expedient in paragraph 94 of IFRS 15.

Foreign currency transactions during the year are translated at the foreign exchange rates ruling at the transaction dates. Monetary assets and liabilities denominated in foreign currencies are translated at the foreign exchange rates ruling at the end of the reporting period. Exchange gains and losses are recognised in profit or loss, except those arising from foreign currency borrowings used to hedge a net investment in a foreign operation which are recognised in other comprehensive income.

Non-monetary assets and liabilities that are measured in terms of historical cost in a foreign currency are translated using the foreign exchange rates ruling at the transaction dates. The recoverable amount of the assets, or, where appropriate, the cash generating unit to which they belong, is the higher of its fair value less costs of disposal and value in use. The recoverable amounts are determined based on fair value less costs of disposal which are based on the best information available to reflect the amount obtainable at the reporting date, from the disposal of the asset in an arm's length transaction between knowledgeable and willing parties, after deducting the costs of disposal. For the estimation of value in use, the Group's management estimates future cash flows from the cash-generating units and chooses a suitable discount rate in order to calculate the present value of those cash flows.

#### 4 OPERATING SEGMENT INFORMATION

For management purposes, the Group is organised into business units based on their products and services and has two reportable operating segments:

- the biochemical segment is mainly engaged in the manufacture and/or sale of chlortetracycline and other related products; and
- the industrial segment is engaged in trading of machinery and the manufacture and sale of automotive parts, through the Group's joint venture and associate.

Management monitors the results of the Group's operating segments separately for the purpose of making decisions about resource allocation and performance assessment. Segment performance is evaluated based on reportable segment profit, which is a measure of adjusted profit before tax. The adjusted profit before tax is measured consistently with the Group's profit before tax except that bank interest income, finance costs and items not specifically attributed to individual segments, such as head office or corporate administration expenses are excluded from such measurements.

Segment assets exclude unallocated corporate assets. Unallocated corporate assets include cash and cash equivalents, income tax receivable and other assets that are managed on a group basis.

Segment liabilities exclude unallocated corporate liabilities. Unallocated corporate liabilities include bank borrowings, income tax payables, deferred tax liabilities and other liabilities that are managed on a group basis.

All revenue from contracts with customers is recognised at the point in time when our customer obtains control of the promised goods, i.e. when products are delivered to the customers' premises for domestic sales or in accordance with the terms and conditions of sale for export sales. The major product line of the Group is the manufacture and/or sale of chlortetracycline and other related products in biochemical segment as disclosed in note 4(a).

Disaggregation of revenue from contracts with customers by geographical location of customers is disclosed in note 4(b)(i).

The credit risk associated with trade receivables is considered relatively minimal due to the Group's large customer base and its geographical dispersion. The Group performs ongoing credit evaluations of its customers' financial conditions. Appropriate allowances for estimated irrecoverable amounts are recognised in profit or loss when there is objective evidence that the asset is impaired. The allowance recognised is measured as the difference between the asset's carrying amount and the present value of estimated future cash flows discounted at the effective interest rate computed at initial recognition.

The Group measures loss allowances for trade receivables at an amount equal to lifetime ECLs, which, except for amounts due from customers with known financial difficulties or significant doubt on collection that are assessed individually, is calculated using a provision matrix. Accordingly, the Group recognised credit loss allowance of US\$165,000 for several customers with significant doubt on collection that is individually impaired for the year ended 31 December 2020 (2019: Nil). As the Group's historical credit loss experience does not indicate significantly different loss patterns for different customer segments, the loss allowance based on past due status is not further distinguished between the Group's different customer bases. The Group assessed that there is no significant loss allowance recognised in accordance with IFRS 9 as at 31 December 2020 and 2019 and no ECL rate has therefore been disclosed.

The Group considered that the entire trade receivable balances have the same credit risk exposure. The expected loss rates are based on actual loss experience over the past five years. These rates are adjusted to reflect differences between economic conditions during the period over which the historic data has been collected, current conditions and the Group's view of economic conditions over the expected lives of the receivables.

### (c) Foreign currency risk

RMB is not freely convertible into foreign currencies. All foreign exchange transactions are conducted with reference to the exchange rates quoted by the People's Bank of China. Payments for imported materials and remittance of earnings out of mainland China are subject to the availability of foreign currencies.

Export sales of the Group are conducted primarily in US\$. For certain subsidiaries, joint venture and associate, funds denominated in RMB may have to be, and from time to time are, converted into US\$ or other foreign currencies for the purchase of imported materials and equipment.

Should RMB appreciate/depreciate against US\$, it may reduce/increase the foreign currency equivalent of such earnings available for distribution by these subsidiaries, joint venture and associate of the Company.

The following table demonstrates the sensitivity at the end of the reporting period to a possible change in RMB exchange rates, with all other variables held constant, of the Group's profit before tax and equity (due to changes in the fair value of monetary assets and liabilities of the Group's foreign subsidiaries).
